Special consideration will be given to applicants proposing to use funding to support early diversion services for veterans. Award recipients will be required to: <ul style="list-style-type: none"> <li>• Convene an interagency "Law Enforcement and Behavioral Health Partnership" group that, at a minimum, must include the criminal justice system and mental health and substance use treatment and recovery systems</li> <li>• Develop and implement a comprehensive plan of evidence-based practices, strategies, and services using a multiagency approach that addresses the three stages of early diversion of an individual with SMI or COD prior to arrest or booking</li> <li>• Integrate the early diversion program into an existing system of care</li> </ul>	State, Local and Tribal Governments

The grant program has two key components: Identify documented causational impacts and determine grant dollars needed to reimburse for those impacts; and priority will be given for one or more of the following purposes: To pay for additional law enforcement activities related to retail marijuana, including costs associated with increased arrests, increased traffic violations, and prevention of out-of-state diversions and trafficking of marijuana; To fund youth services, especially those that prevent the use of; To mitigate other impacts that the cultivation, testing, sale, consumption, 3or regulation of retail marijuana or any other illegal activity related to marijuana has on services provided by an eligible local government	Local Government
