

# FOX RUN REGIONAL PARK MASTER PLAN UPDATE

SEPTEMBER, 2006





#### **Background**

**Fox Run Regional Park** is located approximately three miles east of Interstate 25 on Baptist Road. Opened in 1986, the 417 acre park has experienced increasing use ever since. Fox Run Regional Park is the most utilized county park. Two ponds, the trails through the Fallen Timbers area, the playfields, playground equipment and five group picnic pavilions attract many people on a daily basis – from individual hikers and cross-country skiers to daycare providers and the children they care for. A park maintenance facility for the north district is also located at this park site.







#### **Public Input Process**

Residents of El Paso County residing in the Fox Run Regional Park were invited to complete a survey identifying the needs of future park needs. The survey was published in several local newspapers and tallied in July, 2006. The results of the survey are as follows:

- 6. Improve / expand multi-use fields

#### **Most Popular Proposed New Facilities:**

- 1. Restrooms at ponds
- 2. Cross country skiing / snowshoe areas
- 3. Nature Center
- 4. Outdoor ice rink
- 5. Fishing areas
- 6. Disc golf course
- 7. Fresh water swimming
- 8. Off-leash dog park
- 9. Tennis courts

#### **Reoccurring Comments from the Survey:**

- 1. The park is very good as is. Improvements / expansion should be kept to a minimum.
- Expanded trails.
- 3. Expanded parking, including horse trailer facilities.
- 4. Improve restrooms.


## **Proposed Work**
